- Condition of Sanction:** Any swimmer entered in the meet, unaccompanied by USA-S member coach, must be certified by a USA-S member coach as Being proficient in performing a racing start or must start each Race from within the water. It is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with This requirement.  
The competition course has been certified in accordance with 104.2.2C(4). The copy of such certification is on file with USA Swimming.  
**Operating a Drone in any City of Saint Petersburg Park is against the Law.**  
**Deck changing at all City of Saint Petersburg Pools is prohibited.**  
**All adults participating in or associated with this meet, acknowledge that they are subject to the provisions of the USA Swimming Minor Athlete Prevention Policy ("MAAPP"), and that they understand that compliance with MAAPP is a condition of participation in the conduct of this competition.**

- Pool Spec:** Certified 25 Yard, outdoor pool with a max of 20 short course racing lanes having a minimum depth of 4 feet, at both starting ends, and non-turbulent lane lines. Numerous lanes for constant warm down.
- Medical:** Lifeguards and AED on site and on duty during warm-up and meet.

- Timing Equipment:** Colorado Timing System with scoreboard
- Eligibility:** Open to members CURRENT MEMBERS OF USA SWIMMING. On deck registration will not be allowed.
- Seeding:** 25 yard times will be used for seeding. No Converting Times. Meet will be seeded fastest to slowest.
- Scratches:** No penalty for scratching on the block.
- Entry Limit:** Entries will be limited to keep the meet under 3 hours. Fly Over Starts may be used to control the length of the meet. Swimmers will be limited to a maximum of three (3) events. Swimmers posting entries over the event limit will be considered as entered in the first three (3) events listed. Deck Entries from swimmers already entered in the meet may be accepted. Swimmers can not drop one event to enter a new event. No new heats will be created.
- Entry Form:** Entries must be submitted on Hy-Tek disk. Please enclose hard copy of entries from Hy-Tek along with the disk.
- Entry Fee:** Individual events: **\$5.50 PER EVENT - MAXIMUM THREE EVENTS (3) FACILITY SURCHARGE - \$10.00 PER SWIMMER. \$3 HEAT SHEET SURCHARGE - \$2/SWIMMER OUT OF LSC SURCHARGE**  
ALL ENTRY FEES MUST BE PAID BEFORE THE START OF THE MEET. NO SWIMMERS WILL BE PERMITTED TO COMPETE IN THE MEET, TILL ALL ENTRY FEES ARE PAID. **ALL TEAMS MUST PAY WITH A SINGLE CHECKS. TEAMS PAYING WITH MULTIPLE CHECKS, FROM INDIVIDUAL FAMILIES WILL BE CHARGED A \$1 PER CHECK PROCESSING FEE.**

- Awards:** No awards for 11 and older. All 10 and under events will be scored and awarded by 9-10 and 8&U age groups.
- Rules:** Current USA Swimming Technical rules will govern. Safety Rules, as outlined by USA Swimming, and as recommended by the Head Marshall, will be in effect during all warm-up periods and in all warm-up areas. Prior to the start of the meet, the name of one person other than the coach who will check with the referee about any matter pertaining to the meet must be given to the referee. The coach and only that person will be recognized.
- Proof of Coach/Official Membership** All coaches and officials must sign in with Meet Director and show proof of membership to have access to the facility. **Deck Pass will be accepted for proof of membership.**
- Coach Supervision:** All swimmers must be supervised by a USA Swimming Certified Coach. Any

swimmers attending the meet without a certified coach must take responsibility for finding a certified coach, who will be responsible for them during all warm-ups and sessions of the meet. That agreement must be submitted in writing to the referee before the swimmer is allowed in the meet.

**Warm-Up Schedule:** ALL TEAMS WILL BE ASSIGNED WARM-UP TIMES AND LANES. NO EQUIPMENT IS TO BE USED IN ANY LANE THAT HAS TOUCHPADS. ONE WAY DIVE STARTS UNDER COACHES SUPERVISION MAY BE DONE DURING THE LAST 10 MINUTES OF A TEAM'S WARM-UP IN THEIR ASSIGNED LANES.

\*\*\*Except for racing start, swimmers must enter the pool feet first with one hand touching the deck of the pool\*\*\*NO EQUIPMENT ALLOWED IN THE POOL AT ANY TIME

**Camera Zones:** Per Florida Swimming Rule 223.13, Meet management shall designate and inform the public of CAMERA ZONES at each swim meet where both still and video photography of a race or a competitor may be taken. The entire pool deck at The North Shore Pool is a no camera zone. All locker rooms and bath rooms are a no camera zone. Any individual failing to abide by the rule could be subject to the Florida Swimming Code of Conduct violation as defined in rule 239.2
